WRITTEN UNDERTAKING

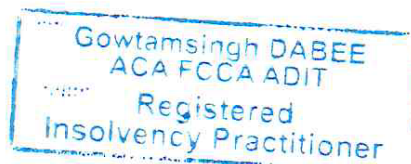
1. I, the hereundersigned, am the Receiver of the Applicant.



ORDER

Upon reading the letters, dated 10th June 2025, from Mr Attorney N Ramasawmy, appearing for the applicant, stating that the applicant is agreeable to provide the undertaking requested for by the respondent and as set out in the document annexed to the said letter and from Mr Attorney D Ramdhur, appearing for the respondent, stating that the respondent has no objection to the amended motion paper provided that the undertaking given by the applicant is recorded, I make the following orders:

- A. I vary the Order granted on the **04 April 2025** in matter bearing cause number **SC/COM/PET/000275/2021** such that the Order shall now read as follows:-
- i. *Ordering and directing the rectification of the register of members of the African Network Information Centre (AfrinIC) Ltd to add details of Cloud Innovation Ltd as per the criteria set out at Section 91 of the Companies Act as its member in the category of Member therein; and*
 - ii. *Further ordering and directing the Registrar of Companies to cause the proper entries to be made in the company records including the register of members of the Respondent to include Cloud Innovation Ltd as a member of the African Network Information Centre (AfrinIC) Ltd, and this within 14 days of the rectification of the register of members.*
- B. I further order and direct the Registrar of Companies to remove any entries she has made to the register of members of the African Network Information Centre (AfrinIC) Ltd pursuant to the Order granted on 04 April 2025 in matter bearing cause number SC/COM/PET/000275/2021 and to rectify same in terms of Prayers A(i) and A(ii) above.
- C. I also record the undertaking given by the applicant as set out in the letter dated 10th of June 2025, termed as "written undertaking", to rectify its records within 15 days from the date of the present Order.
